GRANT DETAILS

11 EPA-selected Environmental Justice Thriving Communities Grant makers will provide subgrants to community-based organizations. These will support capacity building in disadvantaged communities for the pre-development, planning, and assessment of projects addressing communities environmental or public health issues. These grant makers are listed below (by EPA region). You can find the EPA Region map here.

There are 3 tiers of support:

- Tier One grants: \$150,000 for assessment
 - Additionally, \$75,000 will be available for capacity-constrained communitybased organizations through a noncompetitive process
- Tier Two grants: \$250,000 for planning
- Tier Three grants: \$350,000 for project development

ELIGIBILITY

Eligible applicants include:

- Nonprofit organizations, community-based and grassroots nonprofit organizations
- Tribal governments (both federally recognized and state-recognized), intertribal consortia, and Native American Organizations
- Local governments
- Institutions of higher education
